## **Mandai Nature Grant Application Form**

Mandai Nature Fund Ltd. and Mandai Nature International Ltd. (collectively referred to as “**Mandai Nature**”) is dedicated to protecting threatened species, nurturing healthy ecosystems and creating vibrant communities where wildlife and people can thrive and co-exist, in Singapore and Southeast Asia. Through collaborations with like-minded partners, Mandai Nature aims to protect threatened species from extinction, especially those endemic to Asia and often overlooked, including addressing issues of wildlife trade and the fragmentation of habitats. It drives nature-based solutions for climate change focusing on green and blue carbon including protecting and restoring tropical forests, mangroves and peatlands, while working closely with local communities and organisations to create economic opportunities and invest in building skills and conservation capacity on the ground.

Mandai Nature is jointly established by Temasek and Mandai Park Holdings Pte. Ltd. (which, together with its related corporations as defined in the Companies Act 1967, shall collectively be referred to as the “**Mandai Wildlife Group**”).

**Our Goals:** By 2025, we will:

- A. contribute to the recovery and stabilisation of 20 threatened species in Southeast Asia;
- B. protect and restore 100,000 hectares of habitats for threatened species; and
- C. economically benefit communities of 10,000 people, to reduce pressure on species and habitats.

### **Eligibility for Funding:**

Each application will be judged on its own merits. Please address the following supporting criteria in the proposal:

- a. whether the Project is managed with highest levels of integrity and compliant with Mandai Nature’s financial and due diligence framework;
- b. whether the Project is consistent with Mandai Nature’s conservation objectives;
- c. whether the Project is feasible and has a high probability of success;
- d. whether the Project contributes to capacity-building, education, outreach and takes into account human needs;

- e. whether the Project has strong engagement or collaboration with all relevant stakeholders e.g. local communities or local governments;
- f. whether the Project maximises opportunities for the involvement of Mandai Nature and Mandai Wildlife Group's staff;
- g. the Applicant's track record in research (if any); and
- h. any other relevant considerations.

Projects relating to threatened species in Southeast Asia, in particular Asian Species Action Partnership (ASAP) species <https://www.speciesonthebrink.org/>, as well as those under the care of Mandai Wildlife Group and through which direct *in situ* or *ex situ* conservation actions can be accomplished, are preferred.

### **Application Process:**

The Applicant's person in charge of the Project (the "**Project-in-Charge**") shall submit a completed soft copy of this Mandai Nature Grant Application Form together with the following documents:

- i. curriculum vitae of the Applicant (for individuals)/Project-in-Charge (for organisations);
- ii. the Applicant's track record in respect of similar research projects and/or conservation projects (for organisations);
- iii. one (i) reference letter/letter of recommendation from either:
  - a. a former/current collaborator;
  - b. a reputable conservation organisation/individual; or
  - c. a member of a distinguished zoological institution or university;
- iv. completed Mandai Nature Grant Applicant Due Diligence Self-Assessment Form (if applicable); and
- v. signed Conditions for Provisions of Funding, which shall be incorporated herein by reference with the same force and effect as though fully set forth herein.

Mandai Nature reserves the right to:

- (a) request for further information in respect of the grant application, if/when required;
- (b) decide which corporate entity of Mandai Nature or Mandai Wildlife Group shall disburse the grant, in its sole discretion; and
- (c) disregard or reject applications that do not conform to the above instructions and other instructions which may be given by Mandai Nature from time to time.

Only successful Applicants will be contacted about grant approvals and disbursements.

### **Reporting:**

All successful Applicants will be required to submit regular Project reports to Mandai Nature on an average of every six (6) months. Further reporting instructions, including the frequency of report submission(s), will be provided in the grant letter.
